PART II — GENERAL RESTRICTIONS

i Afghanistan, Burundi, Central African Republic, Democratic Republic of Congo, Côte d'Ivoire, Cuba, the Crimea region, Democratic People's Republic of Korea, Islamic Republic of Iran, Republic of Iraq, Lebanon, Liberia, Libya, Myanmar, Puerto Rico, Somalia, Sudan, Syrian Arab Republic, Venezuela, Zimbabwe, **United States of America** (including its states and the District of Columbia), the Virgin Islands of the United States, or any other possessions of the United States of America.

ii Any state, country, territory or other jurisdiction that is **embargoed by the United Nations**.

iii Any state, country, territory or other jurisdiction where the **purchase, ownership and/or use of Tokens would be illegal** or otherwise violate any applicable law.

iv Any state, country, territory or other jurisdiction imposing **high risk of anti-money laundering or counter-terrorist financing** as designated in the Corruption Perceptions Index by Transparency International, FATF warnings, or by the British Virgin Islands authorities.
